

PHOTOGRAPHIC COMPETITION ENTRY FORM 2012

PHOTOGRAPHER'S CONSENT, WAIVER OF LIABILITY, INDEMNITY AND RELEASE.

I _____ (name of artist / photographer), have read the Rules and Regulations of the 2012 Propeller Competition and agree to comply with them in full.

I understand that at all times I **remain the exclusive owner of the copyright** in every image I submit to the competition.

Notwithstanding the above, I irrevocably grant to Fire, The Copper House Gallery and to their employees, officers, agents and assignees (hereinafter referred to as "**Released Parties**"), the right to use, reproduce, adopt, distribute, publish and publicly display the image(s) which I submit, for any purpose in relation to the promotion of, and my participation in the 2012 Propeller Competition. Images submitted, used or reproduced may be retained in the Fire Archive for ongoing display or exhibition and may be disposed of at a future, unspecified date.

This Agreement is entered into in consideration of my participation in the Propeller 2012 competition and the publication of my name in a photographer's credit in connection with any publication of my images by the **released parties**.

I warrant and represent that each image, submitted by me to the Propeller 2012 competition, is original to me in all respects and that I am the sole and exclusive owner of the copyright in the image(s). No part of them is taken from or based on any other work; no part infringes the copyright or any other right of any person; the use by the **released parties** of the photograph(s) in any form whatever will not in any way, directly or indirectly, infringe on the rights of any person.

I release and discharge the **released parties** from any liability by virtue of loss or damage, blurring, distortion, alteration, optical illusion or use in composite form, whether intentional or otherwise, that may occur in the processing or preparation of any published images.

I agree to indemnify the **released parties** from and against any and all loss, damage, costs, charges, legal fees, recoveries, judgments, amounts paid in settlement, penalties, and expenses that may be obtained against, imposed on, or suffered by the **released parties** by reason of: (1.) Any violation or infringement of any proprietary right or copyright. (2.) Any libellous or unlawful matter contained in the photograph(s) / image(s) or (3.) Any invasion of privacy or trespass in the taking or publication of the photograph(s) / image(s) from any use that may be made of the photograph(s) / image(s) by the **released parties**. I also agree to indemnify the **released parties** for any such amounts arising from my breach of any covenant, representation, or warranty of this Agreement.

I declare that I am over 18 years old, and am legally competent to execute this agreement or that I have acquired the written consent of my parent or guardian.

I understand that the terms herein are contractual and not a mere recital, that this instrument is legally binding, and that I have voluntarily signed this document.

- 5 to 8 images to be submitted by email (see rules) or in person.
- Files must be in a folder titled with your name.
- Images should be saved in files 400mm wide x 300mm, supplied with a black background or canvas outside the image area. There's a video on saving your files here: <http://vimeo.com/22069212>
- Files should be 120 dpi saved as jpeg at a quality setting of 6.
- Files must be numbered.
- The entry proposal submission should be as a PDF with a word count of 400 or less.
